Region 14 ESC

Region 14 ESC is NCPA's lead public agency who competitively solicits national master contracts for use by all public agencies. Region 14 ESC is a local governmental agency in the state of Texas, authorized by Chapter 8 of the Education Code. Section 8.008 states the center is considered to be a state agency and each employee is considered to be a state employee.

Joining NCPA

All that is required of you to become a member is to register with NCPA at www.ncpa.us/register. Once you have completed registration, your agency will receive a confirmation email for your records.

There are no costs or obligations for your agency to participate. Registration is free and there are no volume minimums on purchases.



The NCPA Competitive Bid Process

Region 14 ESC issues a competitive solicitation for a product or service on behalf of NCPA and all public agencies.

The solicitation is advertised nationally on behalf of NCPA and all public agencies for a minimum of 30 days.

The solicitation contains language to allow "piggybacking" for states whose laws allow intergovernmental contract use.

The lead agency evaluates the responses based on "Identified Evaluation Criteria" and competitively awards contracts.
